All mail orders must be paid in full, and terms and conditions signed, before eggs or chicks will be shipped.

Ordering Policy

Minimum Order: The minimum number of chicks you can order is 25. We do not book orders without full payment. Orders must be paid at time of booking.

Returned Check Charge - \$25.00

Cancellation Fee – A cancellation fee of 10% of the total purchase and shipping/handling price will be charged for orders canceled after placed. The difference will be refunded in the same form as original payment. Refunds are processed ASAP, but can take up to 3 weeks to be completed.

Purchaser should place their order a minimum of three weeks in advance of the requested delivery date. Newly hatched chicks have a 3-day supply of yolk in their system to help sustain them for their trip. We ship on Tuesdays and Wednesdays. Chicks usually arrive at your post office or mailing address within 2 days. A “notify on arrival (NOA)” phone number is placed on the chick box for the receiving post office to contact you. Notifying your local post office of the impending arrival of chicks is sometimes a good idea.

Delivery and Shipping Information

Your order of chicks will be packaged and sent Priority Mail by the USPS immediately after the chicks are hatched. Chicks are boxed according to the season, so they will have the best chance to survive weather conditions and will arrive in good condition. In extreme temperatures (determined by the USPS) Express Mail may be required. When extremely hot temperatures are reached (mostly during summer months), we will contact you with a modified Express Mail shipping price. We add 4% extra to each order to make sure you get the number of live chicks ordered.

We guarantee live delivery of chicks paid for. Please examine your chicks at the time of delivery to be sure they arrived in good condition. If the shipment arrived in poor condition, please count the number of live chicks and immediately notify S & G. Every effort will be made to replace your loss. We cannot reship replacements of less than 5; however the cost of lost chicks will be refunded. S & G must be notified by phone of losses within two days of receipt for this guarantee to be valid.

SHIPPING CHARGES ARE SUBJECT TO CHANGE AT ANY TIME WITHOUT NOTICE

Disclaimer

Seller warrants that the chicks pursuant to this sale will be live chicks in good condition at the time of delivery by Seller. If the chicks fail meet such terms upon delivery to Purchaser, Purchaser must report such failure to Seller immediately in writing (but no later than thirty (30) days after delivery) and Seller will make appropriate adjustments either by refund or by replacement of the same number of affected chicks which were originally supplied in connection with this sale. It is understood that the mode of adjustment shall be at the sole option of the Seller.

IT IS EXPRESSLY UNDERSTOOD THAT SUCH ADJUSTMENTS ARE THE SOLE REMEDIES OF THE PURCHASER, THE AGGREGATE LIABILITY OF SELLER HEREUNDER WILL NOT EXCEED THE ORIGINAL PURCHASE PRICE, AND PURCHASER SHALL NOT BE ENTITLED TO ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES AS DEFINED IN THE UNIFORM COMMERCIAL CODE AS A RESULT THEREOF.

This limitation of liability shall include without limitation, any death or injury resulting directly or indirectly from any disease in or affecting the chicks, and any damage or injury which may be caused by any information or data provided in connection with the sale.

EXCEPT AS PROVIDED ABOVE, SELLER MAKES NO WARRANTIES, EXPRESSED OR IMPLIED WITH RESPECT TO THE CHICKS OR OTHER GOODS WHICH ARE THE SUBJECT MATTER OF THIS SALE, AND SELLER EXPRESSLY DISCLAIMS ANY AND ALL OTHER WARRANTIES, INCLUDING WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY OF THE POULTRY OR OTHER GOODS, ANY WARRANTY OF FITNESS OF THE POULTRY AND ANY WARRANTY FOR ANY PURPOSE OR OF THE SUITABILITY OF THE POULTRY FOR ANY USE. PURCHASER BUYS THE POULTRY “AS IS” WITH ALL FAULTS.

Purchaser shall examine all shipments in the presence of the delivery agent immediately upon arrival. In the event of any loss or damage at the time of delivery, Purchaser shall forward to Seller an inspection and loss report.

IT IS EXPRESSLY AGREED THAT NO EMPLOYEE, AGENT OR OTHER REPRESENTATIVE OF SELLER HAS ANY AUTHORITY TO BIND SELLER WITH REGARD TO ANY STATEMENT, REPRESENTATION, WARRANTY OR OTHER EXPRESSION UNLESS SAME IS SPECIFICALLY SET FORTH IN WRITING AND SIGNED BY THE PRESIDENT OR SECRETARY OF THE SELLER.

By acceptance of the poultry the Purchaser acknowledges and agrees that the limitations and disclaimers herein set forth are conditions of the sale, and constitute the entire agreement between the parties regarding warranty or other liabilities and the remedy therefore.
